

- On September 14, 2009 President Weston and Dave Rose met with Major Schwartz in reference to the policy review procedures. Major Schwartz is now in charge of furnishing any policy changes to the FOP.
- On September 21, 2009 County Administrative Officer Fred Homan issued a new Cell Phone Usage Policy to all County employees. The policy stated that the use of cell phones, without use of a hands free device, is prohibited while operating any type of motor vehicle while on County business. (Uniformed Police Officers/Emergency Medical department personnel are excluded). The FOP had several communications with the Labor Commissioner and the Police Department over the policy. Police work today often requires the use of a cell phone. The policy, as written, would exclude uniformed officers, but include plain clothes officers in

the ban. As a result of communicating the concerns of the membership, the policy was revised to exclude "all police officers." On September 21, 2009, the Labor Commissioner stated in a letter to the FOP and the Police Department that the exclusion from the Cell Phone Usage Policy is for all police officers.

For the last eight years Officer / Detective Pete Sharman has been a member of the Baltimore County Police Department and the Baltimore County Fraternal Order of Police, Lodge #4. Pete spent the majority of his career in the Wilkens Precinct and the last year in the Narcotics Division (Western C.D.V.I.T.). Tragically, Pete has been diagnosed with Amyotrophic Lateral Sclerosis, commonly know as "Lou Gehrig's" disease.
