SPECIAL RETIREMENT PLAN CONTRIBUTION PROVISIONS FOR PEOPLE NEARING RETIREMENT

If you are nearing retirement, you may want to consider taking advantage of special “catch up” provisions in our deferred compensation plan, which help people who are nearing retirement defer additional money for retirement in their last years of employment. This “catch up” program allows eligible participants to exceed the annual contribution limits to their 457 deferred compensation plan.

The first type of “catch up” is the “Age 50 Plus” catch up. If you contribute to a 457 deferred compensation plan and will be 50 years of age or older by the end of the tax year, you may use this provision to defer an additional \$5,500 in 2010 over the normal deferral limit of \$16,500.

The second type of “catch up” is the “Special 457” catch up. If you are within three years of “normal retirement age” and are making the maximum contribution to your 457 plan, you may be eligible for this provision. If you have not contributed the maximum in the past, you may be able to increase your deferral amount to two-times the maximum contribution limit. For example, in 2010, you may be able to contribute as much as \$33,000. Additionally, this provision is not permitted in the year you retire. This special catch up serves as a one time opportunity that lasts for three consecutive calendar years as long as you are employed. Even if you start late in the first year, that year is counted as one of the three years. You may change or cancel it at any time.

You can only use one of these catch up options in the same year.

- The new premium rates for the period of September 1, 2010 through December 31, 2010 are published in this newsletter. They reflect the following approximate percentages increases: Care first Triple Choice – 4%, United Open Access HMO – 12% and Kaiser’s HMO – 7%. Nationally, health care increases are trending at 13% to 14%.

healthcare carriers that will be available on 1/1/2011.

LEGAL ADVISORY COMMITTEE

The Blake case was argued in Federal District Court in front of a jury of twelve citizens. The trial ran from April 20 through April 27, 2010. After several days of testimony, the jury was given the case on April 28, 2010 for deliberations. They deliberated for approximately 2 hours before delivering a verdict in Blake’s favor. The jury found that former Chief Sheridan violated Blake’s rights under the Americans with Disabilities Act and awarded him \$225,000 in emotional distress damages. For now, the case will continue through legal formalities to resolve the issue of retaliation and the reimbursement of legal fees to the Fraternal Order of Police.

The Employee Relations Act case was argued in Circuit Court on May 10, 2010 in front of Judge Martin. He was familiar with the case and it was apparent that he had read all of the submissions thoroughly. He said that he would issue his decision in a timely manner.

On May 17, 2010 the Legal Advisory committee met to discuss a request from Michele Starks. She retired in December, 2009 on an accidental disability from a line of duty neck injury she sustained in February, 1999. Since that time she has undergone 4 surgeries to repair her injury. After the last surgery in July, 2009, her doctor said she could no longer do the job of a police officer. She notified the

County, who then sent her for a fitness-for-duty exam. The County doctor concurred with Michele’s physician and reported she could no longer be a police officer. The Retirement Board of Trustees then voted to give her an accidental disability pension of 50%. Michele then filed an appeal with the Board of Appeals. In her appeal, she is arguing that the county gave her a disability pension of 50%, but never rated her neck properly. She has a well-documented history of her injury and the ensuing surgeries. She also has two prior disability awards through Worker’s Compensation. In December, 2000 she was awarded a 25% disability after her first surgery. In January 2005 she was awarded a 50% disability after her second surgery. Since that time she has had two additional surgeries, in July, 2008 and July, 2009. She feels she should be awarded the higher disability rating of 66 2/3% because the disability of her neck is at least if not more than the 75% required by the Memorandum of

Understanding to qualify for the higher rating.

- A motion was made to fund the appeal to the Board of Appeals. The motion passed. The committee recommendation was presented to the Executive Board of Directors and the motion passed.
- The retiree subsidy case was argued in Circuit Court on May 24, 2010 in front of Judge Finifter. The FOP won the case in arbitration on July 15, 2008. The County filed for a petition to vacate the arbiter's award. The facts of the case were not litigated again, but the County was able to argue why the decision should be set aside. The FOP attorney, Jeff Gibbs, argued why the decision was valid and that "great deference" should be given to the arbiter's decision. Judge Finifter stated he would review the facts and render a decision.

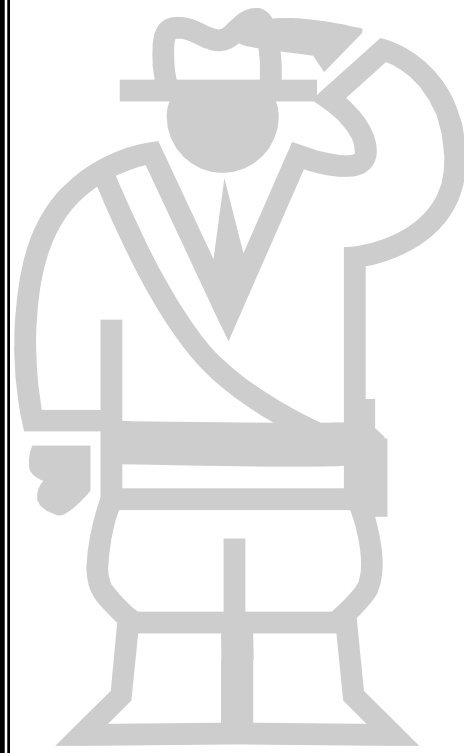
