## Governor O'Malley Signs the Blue Alert Bill Into Law Before Scheduled Date

### The Governor EXECUTIVE ORDER 01.01.2010.14 Blue Alert Program

WHEREAS, The men and women of our law enforcement agencies risk their lives on a daily basis to keep the people of our State safe;

WHEREAS, Violent offenders who harm law enforcement officers pose a serious danger to both law enforcement personnel and our communities at large;

WHEREAS, The rapid dissemination of information about such offenders will facilitate their speedy capture, reducing the risk they would otherwise pose to our communities and our law enforcement personnel;

WHEREAS, Chapter 473 of the Acts of the General Assembly of 2010 established a Blue Alert Program to rapidly disseminate information to assist in locating an offender suspected of seriously injuring or killing a law enforcement officer;

WHEREAS, Chapter 473 of the Acts of the General Assembly of 2010 has an effective date of October 1, 2010; and

WHEREAS, The Blue Alert Program affords Maryland citizens an opportunity to contribute to the safety of our law enforcement officers by providing timely information and should be timely implemented.

NOW THEREFORE, I, MARTIN O'MALLEY, GOVERNOR OF THE STATE OF MARYLAND, BY VIRTUE OF THE AUTHORITY VESTED IN ME BY THE CONSTITUTION AND LAWS OF MARYLAND PROCLAIM THE FOLLOWING EXECUTIVE ORDER, EFFECTIVE IMMEDIATELY:

- A. There is a Blue Alert Program in the Department of State Police.
- B. Purpose. The Blue Alert Program will provide a system for the rapid dissemination of information to assist in locating and apprehending an offender, suspected of killing or seriously injuring a law enforcement officer, whose disappearance poses a serious threat.
- C. Procedures. The Department of the State Police shall:
  - (1) Adopt guidelines and procedures for issuing a Blue Alert;
  - (2) Provide training to local law enforcement agencies on the Blue Alert program;
  - (3) Provide assistance to local law enforcement, as necessary, to locate and apprehend an offender for whom a Blue Alert has been issued;
  - (4) Recruit television and radio broadcasters, local volunteer groups, and other members of the public to assist with the Blue Alert program; and
  - (5) Consult with the State Highway Administration and the Emergency Management Agency to establish a plan for the use of the State's dynamic message sign system to provide information to the public about a Blue Alert.
- D. Terms. This Executive Order shall remain in effect until October 1, 2010.

The opinion of counsel was that the particular facts and circumstances of this case did not make it a viable case to take forward to arbitration, which is where this case would likely have gone. As a result, the member was contacted and agreed to withdraw the grievance.

damages awarded by the jury. The County was contesting the jury's \$225,000 award saying they "abandoned analysis for sympathy." The County feels the award is "excessive" and asked Judge Legg to reduce the award to \$25,000 or schedule a trial on the damages. Judge Legg reviewed the legal motions from both sides and issued a ruling stating "The Court concludes the jury's award of \$225,000 is not grossly excessive and does not shock the conscience. Accordingly, it denies Baltimore County's motion." On July 22, 2010 Baltimore County filed a motion to appeal with the Fourth Circuit Court. They must file the written appeal by August 26, 2010.

- The Employee Relations Act

case was argued in circuit court on May 10, 2010 in front of Judge Martin. On July 7, 2010 he rendered a written opinion in favor of FOP Lodge #4. In his analysis of the binding arbitration statute he stated "The arbitration process as it exists is mandatory and should the parties reach an impasse, then the decision resulting from that arbitration is binding on the County Executive. To this court, logic dictates that in order for the arbitration process to exist as it does and to serve any purpose at all, Jim Smith must be bound by the arbitrator's decision in the sense that Jim Smith is to submit only those items which require an appropriation of funds or the enactment of legislation. **It makes no sense to this court that the arbitrator is required to elect only one proposed package - but the County Executive can then unilaterally and with unlimited discretion choose that which is ultimately submitted to council.** Following this logic, this court acknowledges that the process of binding arbitration would be a worthless endeavor if it were to allow Jim Smith to submit all, none or some of the provisions which he alone felt appropriate and necessary for consideration by the County Council." In his conclusion he stated that "Pursuant to Maryland Rule 2-501 and after careful review of this court, **this court finds that Jim Smith thwarted the clear purpose of the code provisions** by submitting all the arbitrated proposals; some of which required appropriations; some of which required legislation to-

gether with proposals, to this court, which required neither. **This was violative of the code provisions and a failure by Jim Smith to do that which is mandated."**

- The retiree subsidy case was argued in Circuit Court on May 24, 2010 in front of Judge Finifter. As of this report, we are still waiting for a decision.
- The Michele Starks retirement appeal case is scheduled for a hearing at the Board of Appeals on July 29, 2010. A postponement request has been submitted.

- Brother John Cluster advised that at the Maryland State FOP Biennial State Conference in September, 2010 the Gubernatorial endorsement will be made. Lodge 4's State Trustee, Brother Don Patterson, will cast all votes representing Lodge 4's endorsement. Votes from 60% of the delegates in attendance are needed in order for the State Lodge to make an endorsement. If no candidate gets 60% of the votes, no State Lodge endorse-
