## The Courts Have Spoken and the Smith Administration Refuses to Listen!

The following case summaries briefly described here can be found in much greater detail in copies of the Fourword or by reading the court decisions themselves. If you would like additional information on any of these cases please contact the Lodge office for assistance.

During the FY-09 contractual negotiations, FOP Lodge 4 and the Baltimore County Administration did not reach an agreement and went to arbitration according to the requirements specified under the Employee Relations Act. On 03/31/08, the Arbitrator ruled in favor of the FOP's last best final offer. Despite the language of the Employee Relations Act, which states that the County Executive was to submit only the items that require "an appropriation of funds or the enactment of legislation," he submitted each item of the award for legislative consideration. **The FOP filed suit against the administration and on July 7, 2010 the Circuit Court for Baltimore County ruled in favor of the FOP, stating that County Executive Jim Smith violated the Employee Relations Act.** County Executive Jim Smith has filed an appeal to the Maryland Court of Special Appeals.

In September of 2006, after testifying on behalf of a fellow officer about a medical episode that occurred ten years earlier, Detective Bill Blake was ordered to undergo a series of medical tests at the direction of former Chief Terrence Sheridan. The FOP assisted in obtaining a restraining order from the Circuit Court which was subsequently supported by the U.S. Federal District Court. **After multiple depositions, several motions hearings, and a six day jury trial, the jury concluded that Bill Blake's rights were violated under the Americans with Disabilities Act. On July 14, 2010 Judge Legg of the U.S. Federal District Court upheld the jury's decision in favor Bill Blake.** County Executive Jim Smith has filed an appeal to the United States Fourth Circuit Court in Virginia.

In March of 2005, Stan Siedlecki was re-employed after an unsuccessful hearing at the County board of appeals to continue on an accidental disability. For police officers, the County Code provides that if you are recalled from disability retirement, you will return to the same position. Due to his length of absence, he was required to successfully complete a police training academy. The same doctors for the County that said he could return as a police officer would not sign a medical waiver for him to participate in a police training academy because of the physical requirements. **On July 30, 2010 the Maryland Court of Special Appeals ruled for Stan Siedlecki, supporting his disability retirement.** County Executive Jim Smith has filed an appeal the Maryland Court of Appeals.

In September of 2007, the Administration changed the health care subsidy of retirees who left the Department after 2/1/92 and before 6/30/07, despite the contract containing the following language: "The health insurance subsidy in place at the time of retirement shall remain in effect until the retiree becomes eligible for Medicare." A class action grievance was filed by the FOP and a Step IV hearing by an arbitrator was held on 5/9/08. The arbitrator ruled that the negotiated language was a binding promise and should remain at whatever level existed at their retirement. The County filed a petition to vacate the arbitrator's award to the Circuit Court. **After the hearing, a decision was rendered on August 10, 2010 by the Circuit Court in favor of the FOP.** County Executive Jim Smith has filed an appeal to the Maryland court of Special Appeals.

**GRIEVANCE COMMITTEE**

- There were no new grievances filed this month. There is a pending grievance over educational assistance scheduled for August 30, 2010. This grievance involves the question of which fiscal year a reimbursement is credited in if the class begins in one fiscal year and ends in another. The policy is unclear.

**LEGAL ADVISORY COMMITTEE**

- Since the last general business meeting we have received two more court opinions in favor of the FOP's position. Those opinions are summarized below.

- The retiree subsidy case was argued in Circuit Court on May 24, 2010 in front of Judge Finifter. On August 10, 2010, he rendered his decision **in favor of FOP Lodge #4**. The standard of review is very limited. In determining whether to vacate an arbitration award, Courts are generally prohibited from conducting a review on the merits of the arbitrator's award. Because arbitration is a favored method of dispute resolution, courts generally defer to the arbitrator's findings of facts and applications of law. Mere errors of law or fact do not ordinarily establish grounds for a court to vacate or to refuse enforcement of an arbitration award.
- This standard of review has a few exceptions. A court may vacate an arbitration award for fraud or for misconduct, bias, prejudice, corruption or lack of good faith on part of the arbitrator. Additionally, an arbitration award is reviewable to determine whether the award was within the scope of the issues submitted to the arbitration or if the arbitrator failed to consider all matters that were submitted.
- Finally, the court is allowed to vacate an arbitration award if the award involves a mistake "so gross as to work to manifest injustice." Unless the Court finds one or more of these exceptions to apply, the arbitration award must stand. The County made numerous arguments attempting to convince the court that one or more of these exceptions applied.
- In the end, the Court agreed with the FOP's position. The County and the FOP agreed to

submit "any dispute concerning the application or interpretation of the terms of the FY07 Memorandum of Understanding to binding arbitration." The court did not find any of the exceptions which the County argued to apply.

- On August 30, 2010, the Court of Special Appeals issued a **favorable decision in the Stanley Siedlecki case**. In the opinion, the court stated Siedlecki had been receiving disability retirement benefits because the ERS determined he was physically incapacitated from performing the job as police officer. Twelve years later, the ERS re-evaluated him and determined he was physically fit for the position of police officer but never reinstated him because their own doctors would not sign a physician's waiver for him to enter the Police Training Academy. In addition, the ERS Medical Board actually found he could not work as a police officer. Because the position of Employment Investigator was temporary and Siedlecki never accepted it as a permanent position, he was disabled from the last position he held as a "member in service," namely a police sergeant. Therefore, the decision of the Board of Appeals to return Siedlecki his disability retirement benefits is affirmed.
- On July 14, 2010 Federal District Court Judge Legg entered a ruling in the Blake case to resolve the issue of the monetary damages awarded by the jury. The County was contesting the jury's \$225,000 award, saying they "abandoned analysis for sympathy." The County feels

shock the conscience. Accordingly, it denies Baltimore County's motion."

- On July 22, 2010, Baltimore County filed a motion to appeal the Fourth Circuit Court's decision on the Blake case. They must file the written appeal by August 26, 2010. They are appealing as to whether the District Court erred as a matter of law in failing to reduce the award for emotional damages.
- The Employee Relations Act case was argued in Circuit Court on May 10, 2010 in front of Judge Martin. On July 7, 2010 he rendered a written opinion **in favor of FOP Lodge #4**. The County has filed an appeal to the Court of Special Appeals.
- The Michele Starks retirement appeal case that was scheduled for a hearing at the Board of Appeals on July 29, 2010 was postponed.
