On May 4, 2012, the 27th annual Maryland Fallen Heroes Day will be observed at Dulaney Valley Memorial Gardens. On May 15, 2012 the National Peace Officer's Memorial service will take place in our Nation's Capital. Tribute will be paid to our fallen colleagues for their acts of courage and heroism.

Never forget their commitment to the Constitution of the United States of America, and to the enforcement of our nation's laws. Continue the work they started; support their families, and each other in their loss. It is our sustained diligence to the profession of law enforcement that validates the sacrifice of our fallen comrades.

### **GRIEVANCE COMMITTEE**

- On September 27, 2011 the FOP filed a Class Action grievance for changes made to the Absence Control Policy. No date for a Step #3 grievance hearing has been set.
- On February 22, 2012 the County made a motion to have the Brandt Bradford grievance dismissed. The County argued that the interpretation of the retirement system is vested with the Board of Trustees for the Retirement System and the County Board of Appeals. On February 27, 2012 the Hearing Officer dismissed the grievance. The issue will be taken before the Pension Board of Trustees.

### **LEGAL ADVISORY COMMITTEE**

- The FOP filed a Writ of Certiorari in the Maryland Court of Appeals in the Retiree Subsidy case. We feel the decision of the Court of Special Appeals did not address the questions presented.
- The appeal to Circuit Court was filed in the Stanley Siedlecki case.
- We are currently waiting for a court date in Baltimore County Circuit Court in our case against

Baltimore County Executive Kamenetz for not following the procedures as stated in the Employee Relations Act. The County has acted to make changes to the Absence Control Policy and has refused to bargain over those changes. In addition, the County refused to follow the dispute resolution process outlined in the Employee Relations Act. The FOP is asking the Court to direct the County Executive to follow the law.

- The FOP's fee petition for the Blake case was filed in Federal District Court. We are currently waiting for a hearing in Federal District Court.
- The Employee Relations Act case was heard on September 9, 2011 at the Court of Special Appeals. We are still waiting for a decision.

### **PENSION COMMITTEE**

- The Pension Board of Trustees met on March 13, 2012 and approved 109 service, early, vested, incentive, and drop retirements. Two ordinary disabilities were also approved.

### **POLICY REVIEW COMMITTEE**

- The committee reviewed (1) one new policy this month. No issues were identified.
- The only outstanding policy we have is Field Manual 7-15, Photographs, which is still out for an additional Command Review. When it is complete, the committee members will review it again.
- The department is beginning

conversion from the Taser X26 to the Taser X2 and it is expected to be put into use in June. The department is also looking at a camera that attaches to the new model, which begins recording when the Taser is turned on. The FOP will be involved in the construction of a policy for this video attachment. There are many issues that must be addressed before it can be implemented by the department.
