Important Notice Concerning the Board of Trustees of the Employees' Retirement System of Baltimore County

The Pension Board of Trustees has eight positions. Of the eight positions, one is held by the County Administrative Officer and four are held by the appointed department heads of the Office of Budget and Finance, Department of Human Resources, Department of Public Works, and the Police Department. The remaining three positions are elected.

As provided for by the rules and regulations of the Employees' Retirement System of Baltimore County, two members will be elected from the active membership of the system and one retiree will be elected by the retired membership of the system. The persons elected to these positions will serve for four years.

The trustees of the pension system oversee and make policy decisions regarding assets invested in the system. They monitor and evaluate investment manager performance and adherence to policy guidelines, and the performance of the Fund as a whole. Additionally, the trustees review and vote on service retirements, applications for accidental and ordinary disabilities, and good and faithful service considerations.

I cannot stress to you enough the importance of having an elected representative of this organization on your pension board of trustees. Second Vice President Dave Rose turned in the necessary signatures to be placed on the August ballot. He has been your 2nd Vice President for eleven years, and for the last five he has worked exclusively at FOP Lodge #4. Dave is well versed in investment strategies. He has assisted several of our members with difficult questions that affected their decisions to retire, as well as members who have gone through both ordinary and accidental disability process. I feel that Dave has the knowledge and experience necessary to represent all members of the Employees' Retirement System.

Ballots will be mailed to your residence in early August and must be returned post-marked on or before September 4, 2012. Please look for your ballot, and vote for David Rose so he may serve you in this very important position.

County Federation of Public Employees was elected to chair the committee. The committee also made a formal request to Baltimore County for claims data from our health care plans.

- Baltimore County is attempting to obtain agreement from all six County labor unions to make changes to active and retired members' health care subsidies and prescription copays. The Healthcare Review Committee has requested claims data from the County on multiple occasions, but the correct data has not been provided. Negotiations are ongoing.

- On September 13, 2011 the

FOP delivered an Unfair Labor Practice charge against County Executive Kevin Kamenetz as provided in Baltimore County Code 4-5-204(a) for making unilateral changes to the Absence Control Policy. According to the Code, the Director of the Office of Human Resources, George Gay should have selected an arbitrator to hear the facts of the dispute and issue a ruling. On September 16, 2011 the FOP received a letter from George Gay, Director of the Office of Human Resources in response to the Unfair Labor Practice charge. The letter states it is the position of the Kamenetz administration that "The County does not agree to participate in, or pay for a third party agency review." On Octo-

ber 25, 2012 the FOP filed a Complaint for Declaratory Relief and for a Writ of Mandamus in the Baltimore County Circuit Court. Essentially, the FOP was asking the Circuit Court to direct County Executive Kamenetz to follow the Baltimore County Code. On June 20, 2012 the case was heard in Baltimore County Circuit Court by Judge Cox. After a hearing Judge Cox issued a **ruling from the bench directing the County Executive to follow the law.** Baltimore County has since appealed the decision.

- The FOP has filed a Writ of Certiorari in the Maryland Court of Appeals in the Retiree Subsidy case. The Writ of Certiorari was granted on April 20, 2012. Our Brief was filed with the Court on June 15, 2012. Oral arguments are scheduled for September 7, 2012 at 9:30am.
- The FOP's fee petition for the Blake was heard on June 4, 2012 at 4:00pm in Federal District Court in Baltimore. The hearing lasted for about an hour and a half. After presentations from both sides, Judge Legg advised the hearing would be continued on a later date.
- The Stanley Siedlecki case was scheduled for June 15, 2012 in Baltimore County Circuit Court. The case was postponed.
- The Employee Relations Act case was heard on September 9, 2011 at the Court of Special Appeals. We are currently waiting for a decision.
- On June 26, 2012 the Legal Advisory Committee members met to discuss a request from Brandt Bradford. Brother Bradford was hired on December 16, 1974 and retired on a service retirement on

June 16, 1998 and chose Option #4 as his retirement option. Option #4 is a custom option that allows a member to specify a dollar amount of the monthly benefit for the designated beneficiary. It also states that no changes can be made to the designated beneficiary under any circumstances after the first payment of the member's retirement allowance. Eighteen months later, on December 1,

1999, he was reinstated and his appointment date was adjusted to June 2, 1976. Since then he has worked 12 creditable service years and his accumulated retirement funds were transferred back into the retirement system. He has since filed for retirement effective June 30, 2012. He now has a total of 36 years of creditable service years and qualifies for Option #7, the Joint and Survivor benefit. The County Office of Law has issued an opinion stating he cannot change from his prior selection of Option #4. Brother Bradford has filed an appeal with the County Board of Appeals and is requesting funding from FOP Lodge #4.

- The committee members also discussed the incident involving Brother James LaBoard. Mike Marshall was present to answer any questions to which he could respond. A motion was made to fund the case against Brother LaBoard. The motion passed unanimously. The committee recommendation was presented to the Executive Board of Directors. The motion passed unanimously.
