## Important Information Regarding Healthcare

Active Employee Deductions Will Be Divided Between 24 Pays a Year:

- Active employees will now have medical, dental, and vision deductions taken 24 times a year.
- The monthly amount will be split between the first and second pay of each month. For example, if you currently have \$150 deducted from the second pay of the month, you will now have \$75 deducted from both the first and second pay. In the months that you have 3 paychecks, you will not have medical, dental, and vision deductions on the third check of the month.
- The new deductions will begin with your first paycheck in December because we pay one month in advance for our insurance.
- Life Insurance will continue to be deducted out of the first check of the month.
- Flexible Spending Account (FSA) deductions will continue to be deducted 26 times at year out of every paycheck.

OF DIRECTORS REPORT**

- An Executive Board of Directors meeting was held on September 17, 2012. The meeting was called to order at 5:22 p.m. All elected officers and Board members were present. Legal counsel Mike Marshall was also present.
- Motions that were made, after receiving a proper second, were discussed, voted upon, and appear in this issue under the appropriate committee reports.

**REPORTS OF COMMITTEES**

**BYLAWS COMMITTEE**

- Brother Lagna gave the second reading of the proposed change

in the FOP Lodge 4 Bylaws. This change was published in the September edition of *The Fourword*.

### **HEALTHCARE COMMITTEE**

- Sister Greenbeck reported that the premiums for 2013 have been published by the County. Copies were provided at the General Membership meeting and are posted on the FOP Lodge 4 web site.

### **LEGAL ADVISORY COMMITTEE**

- On September 17, 2012 the committee members met to discuss a request for funding a lawsuit from Brother Mike Lauenstein. Brother Lauenstein is requesting that the FOP provide funding for the "costs" or "fees" associated with his case against Baltimore County Government in Federal Court. He stated that Kathleen Cahill is taking his case on a contingent fee basis but that he has to pay associated costs and fees for depositions and expert witness testimony. His case is similar to the Blake case, and the Department of Justice did not reach a settlement with the County in his case. After discussion between the committee members, a motion was made to pay the "fees" and or "costs" incurred in the case. This does not include attorney fees. If the case is won or settled, Brother Lauenstein or Baltimore County would have to reimburse Lodge #4 within 30 days of receiving a settlement check, court/jury award or a fee reimbursement.

### **NOTE TO MEMBERS:**

The December General Membership Meeting will be held on Monday, December 17, 2012. This is the THIRD Monday of the month.

The motion passed unanimously. The committee's recommendation was presented to the Executive Board of Directors, where the motion passed with one abstention.

- On September 12, 2012 our labor attorney asked for documents under the Freedom of Information Act in reference to the loan that was approved by the Pension Board of Trustees from the Employees' Retirement System. We are waiting for those documents to arrive.
- On June 28, 2012 the County filed an appeal of Judge Cox's Circuit Court decision in the Absence Control Policy case to the Court of Special Appeals. No hearing date has been set.
- Oral arguments were made on September 7, 2012 at 9:30 am in the Maryland Court of Appeals for the Retiree Subsidy case. We are waiting for a decision.
- There is still no date for the continuation of the FOP's fee petition for the Blake case that was heard on June 4, 2012 at 4:00 pm in Federal District Court in Baltimore. Since the meeting we received a hearing date of November 7, 2012.
- The Stanley Siedlecki case was scheduled for June 15, 2012 in Baltimore County Circuit Court. The case was postponed. It has not yet been rescheduled.
- The Employee Relations Act case was heard on September 9, 2011 at the Court of Special Ap-

peals. We are still waiting for a decision.

- The Brandt Bradford case was scheduled at the Board of Appeals but both attorneys have conflicts on that date so it will be rescheduled.

- The James Laboard case has been scheduled for December 11, 2012 in Baltimore County Circuit Court.

### **PENSION COMMITTEE**

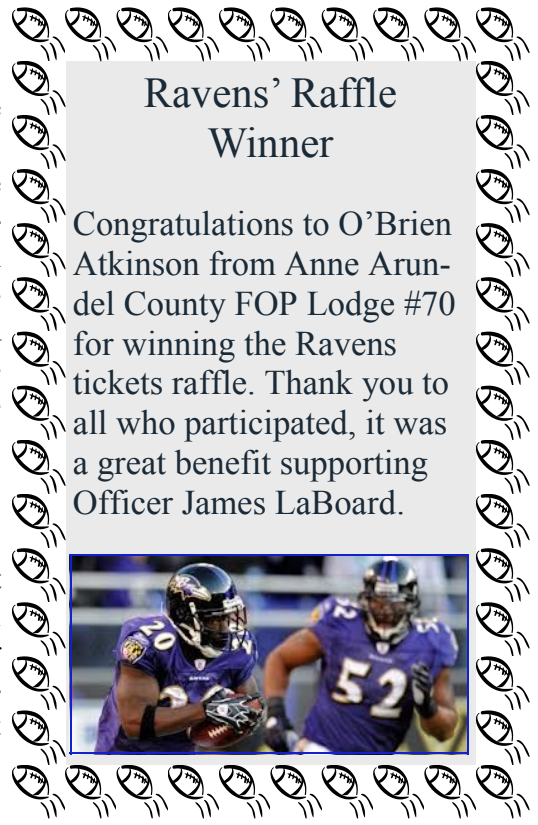
