**DONATION REVIEW
COMMITTEE**

- The committee met on October 15 and the following motions were made and discussed:
- To donate \$250 to the Charles N. Armetta Memorial Fund as established by the Harford County Municipal Lodge 128. Ofc. Armetta died accidentally on September 8, 2012.
- To donate \$300 in lieu of buying

**LEGAL ADVISORY
COMMITTEE**

- The Legal Advisory Committee received a request from Montgomery County FOP Lodge #35. The Montgomery County Government has mounted an aggressive campaign to get the voters to approve Question B. If Question B passes, FOP #35 will lose part of their 30 year collective bargaining law. The outcome will be the loss of “effects” bargaining for FOP members in Montgomery County. FOP #35 is trying to raise \$100,000 to purchase cable time, send out one mailer to voters and launch a meaningful internet campaign. They have already committed significantly more than that amount of money defending their ballot petition in court and in their campaign. They are requesting a contribution of \$1000 or more to help them halt the first attempt to repeal local collective bargaining rights for police officers in Maryland. If this succeeds in Montgomery County, it may encourage other jurisdictions to do the same or worse. They are asking for PAC donations to “Citizens For Effective Law Enforcement Against Question B” (A.K.A. CFELE). Donations to ballot question political committees are unlimited and do not count against an existing PAC’s aggregate limit for contributions. In speaking

with President Weston and First Vice President Comegna, who chairs the PAC Committee, donations for ballot questions do not have to come from PAC fund. Donations can come from the General Fund.

- The Maryland State FOP Board unanimously approved a \$10,000 grant on October 16, 2012 at a special meeting. A motion was made to donate \$1,000 from our general fund to FOP #35. The motion passed. The committee recommendation was presented to the Executive Board of Directors on October 22, 2012 and it passed.
- On October 11, 2012 we received most of the documents our labor attorney requested under the Freedom of Information Act in reference to the loan that was approved by the Pension Board of Trustees of the Employees’ Retirement System. In reviewing the documents, our attorneys did not see any documents indicating the County has met the IRS requirements and

there is no signed document indicating the terms of the loan. We will be sending the County a pre-litigation demand letter stating we have identified these deficiencies in the loan and demand the County comply by a certain date or we will file suit.

- On June 28, 2012 the County filed an appeal of Judge Cox’s Circuit Court decision in the Absence Control Policy case to the Court of Special Appeals. No hearing date has been set.
- Oral arguments were made on September 7, 2012 at 9:30am in the Maryland Court of Appeals for the Retiree Subsidy case. We are waiting for a decision.
- The fee petition for the Blake case was scheduled for November 7, 2012 at 2:00pm in Feder-

al District Court in Baltimore. (\$445,876).

- The Stanley Siedlecki case was scheduled for October 30, 2012 in Baltimore County Circuit Court. It has been postponed. It is now scheduled for January 22, 2013 at 9:30am.
- The Employee Relations Act case was heard on September 9, 2011 at the Court of Special Appeals. We are still waiting for a decision.
- The Brandt Bradford case is scheduled for November 15, 2012 at 10:00am at the Board of Appeals.
- The James Laboard case has been scheduled for December 11, 2012 in Baltimore County Circuit Court.

PENSION COMMITTEE

- The Pension Board of Trustees met on October 9, 2012 and approved 31 service, drop, vested, early retirement, and lump-sum death benefits.

POLICY REVIEW COMMITTEE

- The committee received five (5) policies for review this month. One policy needed to be addressed with the Administration.
- On October 1, 2012 we met with the administration to ask several questions and identify several problems with the draft policy for the Point of View Video System (PVVS) for the Taser that we received. There was an exchange of ideas and explanation of problems from both the Administration and the

FOP. Everyone realized that these issues need to be addressed before any pilot program can begin. On October 12, 2012 we received a revised draft policy from the Administration. The committee members met to discuss the policy and respond. On October 17, 2012 I met with Col. Burris to present the proposal. The committee has informed the Administration that we are against any use of the PVVS.
