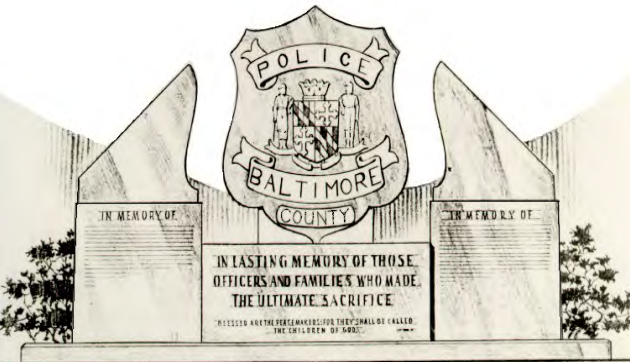

GRIEVANCE COMMITTEE

- On January 4, 2016, the post hearing memorandums in our step 3 grievance over the health care splits were submitted. The decision from Hearing Officer Stahl was received and our grievance was denied. The decision was short and offered very little explanation. We have 30 days to appeal to step 4. The Grievance Committee will be discussing the option with our counsel.

**LEGAL ADVISORY
COMMITTEE**

~Dave Rose~

- The retiree health care subsidy case was presented at the Maryland Court of Appeals on November 9, 2015. We are waiting for a decision.
- On February 2, 2016 we filed a Temporary Restraining Order against the Chief of Police for an

order placed against one of our members that we feel violated the Americans with Disabilities Act (ADA) by compelling medical treatment. The hearing was in front of Judge Alexander and at the conclusion of the hearing he granted the restraining order and scheduled a hearing on the merits for February 12, 2016.

- The County could not make the hearing on February 12, 2016 so the court scheduled it for February 10, 2016. The hearing was in front of Judge Nagle and lasted all day. At the conclusion of the hearing, Judge Nagle ruled from the bench to dissolve and that the order for compelled medical treatment could remain in place until a hearing on the merits of the case could be heard.
- There is a suit filed in Baltimore County Circuit Court. There has not been a schedule set by the court.
- We also have another member in a similar position in another precinct. The Legal Advisory Committee has agreed to support this case as well.
- The Brandt Bradford case was presented at the Court of Special Appeals on February 8, 2016. On February 24, 2016, nearly 4 years after he retired, the court issued a decision in favor of Bradford.
- Brandt Bradford retired in 2012 from the Baltimore County Police Department. The County Employee Retirement System denied a benefit he felt he earned for his 35 years of service. He appealed the decision of the ERS to the County Board of Appeals on April 4, 2013. In an opinion dated October 18, 2013 the Board of Appeals reversed the County ERS stating Bradford was entitled to the earned benefit.

The Fourword

- The County filed an appeal to the Baltimore County Circuit Court and at a hearing on December 12, 2014 Judge Stringer issued an order affirming the Board of Appeals decision for Bradford.
- The County filed another appeal on January 12, 2015 to the Maryland Court of Special Appeals. The case was heard by the Court on February 8, 2016 after a couple of postponements. The Court issued an opinion dated February 24, 2016 affirming the Circuit Court decision.
- Brother Bradford has won this case on three appeal levels. Brandt's monthly pension should be adjusted to reflect option #7 and the current deduction recalculated. The ERS must now refund him for the deductions it should not have taken.

LEGISLATIVE COMMITTEE

~Cole Weston~

- HB 1016 was submitted containing all 23 recommendations made by the Public Safety and Policing Workgroup for changes to the LEOBR. The Maryland State FOP Legislative Committee met with the Chiefs and Sheriffs in an effort to work on joint amendments to the house bill..
- On February 23, 2016 testimony was presented in opposition of those recommendations.

NEGOTIATION COMMITTEE

- On February 1, 2016, impasse was declared in the negotiation process. The committee will continue to meet. Arbitration dates are set for March 18 and 21, 2016.

PENSION COMMITTEE

~Dave Rose~

- On February 18, 2016, the Pension Board of Trustees met and approved eighteen (18) retirements. Three (3) were from the police department.

POLICY REVIEW COMMITTEE

- The committee members reviewed nine (9) policies this month. There were no bargaining issues identified.
- The Body Worn Camera program is progressing. The department has received some equipment from the vendor and has begun testing with different type uniforms and daily police scenarios. There are still many issues with implementing the program such as developing a policy for use, redaction, PIA requests, etc.
- The Legislative Committee in Annapolis has completed their task of submitting recommendations to the MPCTC for Body Worn Camera minimum standards. Those standards have been received by the committee which intends to use them for guidance.
- The Policy Review Committee will review the policy just as it did for the Taser Camera program and will seek to negotiate on items it deems necessary to discuss with the administration.

SCHOLARSHIP COMMITTEE

- The cut-off date for return was February 1, 2016. 38 applications were received by the committee. The committee will meet to narrow down the applicants and then conduct interviews.

GOOD OF THE ORDER

- During the month of February FOP Lodge #4 sent two (2) cards and flower arrangements to bereaving members. Two (2) donations were made in lieu of flowers. Nine (9) thank you cards were received. One (1) fruit basket was sent to a member recovering from illness.

A proposed change to the Constitution and Bylaws of Baltimore County Lodge # 4 of the Fraternal Order of Police, Incorporated.

Whereas: Each subordinate lodge is entitled to one (1) delegate for each fifty (50) active members as representation at the National Biennial Conference and

Whereas: Each subordinate lodge is also entitled to one (1) delegate for every fifty (50) active members as representation at the State Biennial Conference and

Whereas: In order to fully represent the members of F.O.P. Lodge # 4, we should strive to take our total delegation, when approved.

NOW THEREFORE BE IT RESOVLED THAT: The Bylaws Article IV Sections 5, 6 and 7 shall be repealed in their entirety and reenacted as follows (**bold text indicates new language**):

SECTION 5: ELECTION OF DELEGATES

Delegates and alternate delegates who represent the Lodge at either the National or State Biennial Conferences of the Fraternal Order of Police, shall be elected by the Lodge in the same manner as set forth in the Constitution and Bylaws for the election of Line Officers and Non-Line Board Members.

Any lodge member seeking election as a Conference Delegate or Alternate must have attended four (4) meetings in the preceding year (October General Business Meeting to September General Business Meeting), in order to be eligible for election. In addition, the President and Chairperson of the Executive Board of Directors may also nominate individuals who have served actively on committees, but have been unable to attend the required general business meetings as permitted in the Constitution, Article V, Officers, Section 2.

Proof of attendance shall be documented through the Attendance Roster available at each General Business Meeting, which is signed by each member attending the meeting.

SECTION 6: APPOINTMENT OF DELEGATES:

In the event that a lesser number of delegates were nominated than was approved by the Executive Board of Directors, the President has the authority, subject to the approval of the Executive Board of Directors, to appoint additional delegates up to the number previously approved by the Executive Board. The President shall also have the authority, subject to board approval, to appoint replacement delegates if an elected delegate is unable to attend a conference.

SECTION 7: NATIONAL BIENNIAL CONFERENCE

At least four (4), but no more than one (1) for each fifty (50) Active Members, shall be elected/**appointed** to represent the Lodge as delegates to the National Biennial Conference. Said delegates shall be elected/**appointed** only in even-numbered years, beginning in November 1986, and shall be Active members in good standing of the Lodge. A portion of the delegation shall consist of the President, Lodge Secretary, Chairperson of the Executive Board of Directors, State Trustee, and those elected/**appointed**. The President shall serve as the Lodge Caucus Chairperson.

SECTION 8: STATE BIENNIAL CONFERENCE

At least five (5), but no more than one (1) for each fifty- (50) Active members, shall be elected/**appointed** to represent the Lodge as delegates to the State Biennial Conference. Said Delegates shall be elected/**appointed** in the odd-numbered years beginning in November 1985, and shall consist of the President, Lodge Secretary, Chairperson of the Executive Board of Directors, State Trustee, the State Trustee-Elect, and those elected/**appointed**. The President shall serve as the Lodge Caucus Chairperson.

Section 8 of this Article shall be renumbered accordingly to Section 9
