Re: *Baltimore County v. FOP*

Dear Mr. Clash-Drexler:

In response to your emails from earlier this week and to your email request today that any check be sent to Cole Weston, I am sending a check to him by courier today in the amount of \$84,866.00.

The attached spreadsheet reflects the five healthcare payments made by FOP retirees during Calendar Year 2014 to date plus accumulated interest.

Three payments covering the period of February to April made January 31, February 28 and March 31, respectively, were made pre-judgment. Therefore, pre-judgment interest at 6% was accrued through April 28, 2014. Post-judgment interest of 10% was added to the combined pre-judgment payments and pre-judgment interest through June 4, 2014.

Two payments covering the period of May to June made April 30 and May 30, respectively, were post-judgment. The check paid to the FOP by the County on May 30, 2014 returned these two deductions. Therefore, post-judgment interest of 10% was added only to the April 30, 2014 payments and calculated through May 30, 2014.


The attached spreadsheet indicates the total of payments returned plus accrued interest is \$140,448.38. A portion of the May 30, 2014 check from the County that is attributable to this February to June period is \$55,582.38.

Therefore, the balance paid by check (copy attached) today to FOP totals \$84,866.00.

We believe the payments today and on May 30, 2014 fully comply with the Court's Orders.

Please advise the Court as soon as possible that FOP does not intend to file a Response in Opposition to the County's previous Certification of Compliance with Prior Court Orders and copy me on any such communication.
