### President's Message

At the November Executive Board of Directors meeting, the Expenditure Review Committee presented a report highlighting that the lodge currently spends approximately \$40,000 annually to print and mail the newsletter. In light of this significant expense, the committee recommended transitioning to a digital-only format, making the newsletter available via email. This move would also be supported by the electronic versions already accessible on the lodge's website and app.

The Executive Board voted unanimously to approve the recommendation.

The transition will be phased in over the next several months, with the last printed version for active members being the January newsletter, and for retired members, the final printed version will be the April newsletter.
