A Look Back at 2024: A Year of Challenges and Achievements

Dear Brothers and Sisters.

As we reflect on the past year, it is clear that 2024 presented us with numerous challenges. However, we rose to meet each one with determination and unity. Below is a summary of some of the key events and accomplishments of the year.

The year began with significant activity in the General Assembly, where we were deeply involved in lobbying for several bills. In addition, we worked quickly to assemble a negotiating team, retain legal representation, and prepare proposals as the impasse date of February 1, 2024, approached.

Our members faced unprecedented situations with the in-custody death and officer-involved shooting in Precinct 4 on consecutive days. During this time, we were also notified of a pending Grand Jury proceeding and eventual indictment of several of our members in Precinct 1 related to an incident in Baltimore City. We acted swiftly to secure separate counsel for each involved officer.

Baltimore County experienced the collapse of the Key Bridge. Many of our members were on the front lines, participating in search and rescue operations during this critical event.

Several members were involved in a fatal pursuit in Precinct 2. During this time, we were also in the process of negotiating settlements for the COVID and Military grievances. Despite the challenges, we successfully ratified a new Memorandum of Understanding, which will guide our efforts in the future.

We celebrated the department's 150th Anniversary in grand fashion at Big Truck Brewery. This was a major event that brought our members together and showcased the strength of our agency.

As we moved into the fall, we faced legal battles when our first officer went to trial in Baltimore City. After a 6-day bench trial, the officer was found not guilty on all charges, and shortly thereafter, charges against three other officers were dismissed. Though the legal and expert fees for these cases totaled over \$230,000, I'm proud to say that these costs were covered in full within our 2024 budget. Additionally, the Attorney General's reports regarding incidents earlier in the year confirmed that all officers acted appropriately and lawfully.

We also had the trial in Baltimore County for the man who was charged with four counts of attempted murder for an incident in Cockeysville in February 2023, where one of our members was shot. At the conclusion of the trial, he was found guilty on those charges. Sentencing will be in 2025.

Looking Ahead to 2025:

As 2024 came to a close, we shifted our focus to 2025. We began preparing for contract negotiations and worked diligently to secure sponsors and support for critical legislation in both the 2025 General Assembly and local county legislation. Our goal is to finally resolve the Military grievance once and for all.

Throughout this year, your lodge leadership, executive board, and many committee members worked tirelessly on behalf of our membership. In 2025, we will strive to be even more effective and efficient. While we know there will be challenges and disagreements ahead, we will face them together, and we will overcome them as we always have.

Thank you for your continued trust and support. Together, we will make 2025 another successful year.

Healthcare Review Committee - Mike DiCara

- The quarterly meeting of the County's Healthcare Review Committee was held on December 12th.
- The recent, undisclosed changes to the Cigna Surround Medicare plan were discussed. The County believes these changes were needed to control costs while still offering a high-quality plan. Labor's consultant agreed that these changes were reasonable, but we requested more transparency in the future so that our membership can be informed prior to open enrollment.
- The County asked us to remind our active members about the new medical clinic for County Employees located at 305 Washington Avenue. It is on the model of an "urgent care" with two exam rooms and an on-site lab. It is totally free for County employees and insurance isn't billed, which allows all County employees to use it, even those who don't have County insurance.
